Voters Approve \$164.6 Million in School Construction

TRENTON, April 23, 2009—Voters approved 15 of the construction referendums in 19 districts on Tuesday for a total of \$164.6 million in school construction, according to the New Jersey School Boards Association.

Tuesday, April 21 was the <u>Annual School Election</u>, the date when voters in 90 percent of New Jersey school districts elected school board members and voted on their districts' annual budgets. The Annual School Election is also one of five dates a year on which school boards can propose referendum questions on construction projects. The remaining dates for school bond elections this year are Sept. 29 and Dec. 8.

Of the total amount of construction proposals approved on April 21, more than \$41.6 million will be eligible for state school-facilities reimbursement.

Keyport - Passed Repair roof and install solar panels at Central Elementary School and at administrative offices Total amount - \$3,900,423 Amount eligible for state aid - \$1,689,294

MORRIS COUNTY

Butler - Rejected Bleachers and field improvements at elementary school Total amount - \$350,885 Amount eligible for state aid - \$140,354

OCEAN COUNTY

Lakehurst - Passed Renovate elementary school, including roofing, HVAC and fire systems Total amount - \$4,754,897 Amount eligible for state aid - \$3,583,210

PASSAIC COUNTY

Prospect Park - Passed Construct an addition for pre-kindergarten, replace boilers and other renovations Total amount - \$4,256,717 Amount eligible for state reimbursement - \$1,576,795

SUSSEX COUNTY Frankford Township - Passed Renovations to elementary school, including repairs to roof, doors, restrooms and floors Total amount - \$1,296,205 Amount eligible for state reimbursement - \$518,482

Green Township - Passed

Partial roof replacement at elementary school Total amount - \$693,500 Amount eligible for state reimbursement - \$277,400

Hardyston Township - Passed

Roof replacement at middle school Total amount - \$1,732,500 Amount eligible for state reimbursement - \$693,000

(Note: The amounts eligible for state reimbursement include state school facilities grants and state school facilities debt service payments, but may not include other sources such as Clean Energy rebates for solar projects.)
